Boutique Consignment Agreement

The Boutique at the GSQA Quilt Show 2020 is available to current GSQA members. The Boutique will charge and collect sales tax on all items sold. Sales tax will be paid by the purchaser. Sales tax reporting will be the responsibility of GSQA not the individual members. GSQA shall charge a commission rate of 13% on all sales. The gross sales proceeds, less commission will be paid to the members within 10 days of the end of the 2020 GSQA Quilt show.

We ask that all members placing consignment items in the boutique volunteer to work at least 2 hours during set up, show hours or clean up time to help the boutique organizers and to give members an opportunity to ensure the boutique runs smoothly. You can choose your volunteer time on the boutique registration form.

It is expressly understood by each member that GSQA shall not in any way be responsible or liable for any loss, damage or theft of any member's consignment goods, equipment or personal property that may occur as a result of any occurrence whatsoever.

The member is responsible for setting prices and tagging each item offered for consignment. Item tags must include the GSQA member number and price. Tags should be attached by pins (preferably safety pins) rather than adhesive labels, with the exception of hard surfaced items. Items may include "made by" labels or maker name can be included on sales tags. Sales prices must be even dollar amounts.

Items can be turned in at the January 2020 GSQA meeting and at the Rosebud Auction. Members may mail in submissions to Joel Sellers, 8215 Birch Street, New Orleans, LA 70118-2821. The member is responsible for insurance and delivery costs and accepts all risks for loss or damage in shipment.

Unsold items can be picked up at the Boutique on Saturday after the close of the show. Items will not be mailed. Unclaimed items will be held by Joel Sellers to be picked up at the member's convenience. (8215 Birch Street, New Orleans, LA 70118, 504-756-6422, pracdx@bellsouth.net).
